

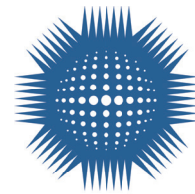

WHY TAKE NEBOSH ENVIRONMENTAL MANAGEMENT CERTIFICATE?

This qualification is designed for anyone who has responsibilities for managing environmental issues as part of their work. The qualification is designed to be globally relevant and benefit companies in all industry sectors who are seeking to implement effective environmental management systems, increase positive environmental impacts, and reduce negative environmental impacts.

Upon the completion of the qualification, learners will be able to understand a range of environmental issues in order to improve performance and reduce harm, work with an environmental management system and contribute to continual improvement, recognise environmental aspects and evaluate current controls, support decision-making with ethical, legal, and financial arguments and understand the links between organisation's activities and wider environmental issues

Overview

The qualification will aid learners to justify environmental management in the workplace, recognise which workplace activities may be subject to environmental legislation or enforcement, assess environmental aspects and impacts, and evaluate existing controls, support environmental emergency planning, understand the importance of reducing environmental harm, outline the issues associated with waste and its management and explain the pros and cons of various energy sources and how to use them more efficiently.

Learning Outcomes:

Upon completion of this course, the participants should be able to:

- Justify environmental management in the workplace using ethical, legal and financial arguments, linking these to wider environmental issues including sustainable development.
- Recognise workplace activities which may be subject to environmental legislation or enforcement.
- Understand the requirements of, and work within, an environmental management system, whilst contributing to continual improvement.
- Assess environmental aspects and associated impacts, determining significant aspects and evaluating current controls.
- Support environmental emergency planning.
- Understand the importance of reducing environmental harm; identify sources of noise, air, and water pollution; and suggest suitable control measures.
- Understand the issues associated with waste and support responsible waste management.
- Understand the benefits and limitations of a range of energy sources, and suggest suitable measures to increase energy efficiency.

Assessment: **Written and Practical Exam**

Target Audience:

- The assessments are offered and must be answered in English only.

Progression Route and Further Studies:

Learners pursuing NEBOSH Environmental Management Certificate can progress specific industry applications, as follows:

1- NEBOSH Fire Safety

2- NEBOSH HSE Certificate in Process Safety Management

Learners could also take a more general approach for their further studies via NEBOSH General Certificate in Occupational Health and Safety.

Benefits to Employers:

- The importance of the effect of business activities on the environment has long been acknowledged. Many companies, irrespective of size or type of business, now recognise that a more efficient use of resources can also bring substantial cost savings (eg, raw materials, waste disposal, energy and transport).
- A growing awareness among the general population means that organisations are expected to understand and manage their impacts proactively. Increasingly, business partners as well as customers, prefer to deal with environmentally responsible companies. Banks, insurers and other sources of finance may avoid businesses that do not take environmental matters seriously and expose themselves to unnecessary environmental risk.
- Those that are considered environmentally aware may benefit from better access to capital and lower insurance premiums. The business impact of environmental incidents is also compelling: in addition to the direct cost of cleanup, employers can find themselves dealing with criminal prosecution, claims for compensation, adverse publicity and harm to both business reputation and profitability. Failure to act in an environmentally responsible manner can bring businesses into conflict with the local community, pressure groups and other employers

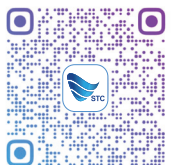
